The meeting was chaired by the Hon'ble the Chief Justice, Justice Sanjib Banerjee who welcomed all the members present.

Discussion was held on commencement of academic programmes from July, 2023 -24 and the following decisions were taken:

#### RESOLUTION:

- i. Advertisement for faculty should be carried out first.
- ii.Advertisement for students to be done by the end of the month of April, 2023.
- iii. Examinations to be conducted by the 1st or 2nd week of May, 2023. (Online examination may be conducted subject to cost).
- iv. To admit students from Bangladesh, Nepal, Bhutan, and United Arab Emirates subject to feasibility.
- v. The draft Budget for the year 2023-24 to be ready by next week.
- vi. To prepare a timeline for activities upto the opening of the curriculum on 3rd July, 2023.
- vii.Accept the Vice-Chancellor's suggestion of having BA.LLB, BSC.LLB, BBA.LLB subject to flexibility,adherence to the Bar Council of India guidelines and permission.
- viii.ERP to be prepared with the person which the state government suggests, maybe in consultation with NIC and other agencies.
- ix. Reservation for domicile to be at 50% as per the state reservation policy.
- x. The Executive Council should hold a meeting on 18th April, 2023 before the next meeting of the Governing Council scheduled on 20th April, 2023.

The meeting ends with a vote of thanks to the Chair.
