The Vice-Chancellor of National Law University Meghalaya (NLU Meg) is pleased to convene the Emergency 7th Academic Council Meeting of the University, scheduled to be held on 18th June 2025 at 5:00 PM at Mayurbhanj Complex, Nongthymmai, Shillong – 793014.

Agenda for the 7th Meeting of the Academic Council

- 1. Commencement of the July 2025 Trimester
- a) Faculty Availability: There is currently a shortfall of faculty for 12 courses, leading to a higher workload for the existing faculty. (Annexure 1.a)
- b) Accommodation for Incoming Students: Furnished accommodation for the incoming batch of 63 undergraduate and postgraduate students will not be fully ready. As per the most recent communication with the vendors, the complete furnishing will require an additional two weeks. The work order was issued on 13 June 2025. (Annexure 1.b)
- c) Proposed Options for Commencement of the Academic Session:
- Option 1: Commence all trimesters as per the original schedule. However, considering the unavailability of both faculty and hostel accommodation, this may not be feasible.
- Option 2: Begin classes for the senior undergraduate (7th and 4th trimesters) and postgraduate (4th trimester) batches on 7 July 2025. The first trimester for both undergraduate and postgraduate programmes will commence on 21 July 2025. (Annexure 1.c.i)
- Option 3: Commence the academic session for all programmes on 21 July 2025 and compensate for the lost teaching hours by scheduling additional classes on Saturdays and holidays, from 21 July until the end of the trimester on 13 September 2025.

2. Temporary Academic Appointments (Annexure 2.a)

Proposal for the appointment of **Postdoctoral Fellow(s)** and **Associate Research Professor(s)** on a one-year contract to address teaching and research needs during the interregnum period of the July trimester, until permanent appointments are made.

To deliberate on whether to announce the results of PhD admissions for the July 2025 cycle, considering the unavailability of competent supervisors (faculty).

Agenda Item 1: Commencement of the July 2025 Trimester

a) Faculty Availability

Discussion:

The Hon'ble Vice-Chancellor highlighted that the shortfall has arisen due to the resignation of two Law faculty members and three from the domain-specific disciplines. Members of the Academic Council expressed concern over maintaining academic quality and ensuring continuity in programme delivery.

Resolution:

It was resolved to consider the commencement of classes for new students of all programmes from 21 July 2025, while allowing ongoing students (UG Trimester 7 and 4, and PG Trimester 4) to begin classes as per the academic calendar on 7 July 2025. This matter was referred to Agenda Item 2 for further deliberation.

Agenda Item 2: Accommodation for Incoming Students

Discussion:

The Registrar informed the Council that renovation works in the newly allotted IIM hostel block are expected to conclude within the week. However, furnishing delays remain, with vendors indicating a maximum of 25 days from the date of work order issuance (12 June 2025). The Hon'ble Mr Justice H. S. Thangkiew advised the Registrar to expedite the process by engaging with vendors directly and pressing for early completion to ensure academic continuity.

Agenda Item 3: Temporary Academic Appointments (Annexure 2.a)

Discussion:

The Academic Council discussed the advertisement and recruitment of temporary and/or lien-based academic appointments for the July 2025 trimester, in light of urgent staffing needs. Given the scheduled commencement dates of 7 July and 21 July, the Council acknowledged the necessity of immediate academic support.

The Hon'ble Mr Justice H. S. Thangkiew observed that there would be no objection to temporary appointments, provided there are suitable and willing applicants. Shri CVD Diengdoh, IAS, noted that as per Bar Council of India requirements, a minimum of six full-time faculty members in the first year with at least 10 in the third year—including those at the Associate Professor/Professor level—is essential. He recommended increasing the number of Associate Research Professors.

Resolution:

The Council approved the engagement of **two Associate Research Professors in Law** and **one in Data Science and Management**. The Vice-Chancellor confirmed that this recommendation would be placed before the **Executive Council (EC)** on **23 June 2025 (Monday)**. Upon EC approval, advertisements will be released on the same day, with an expedited application deadline of **29 June 2025 (Sunday)**.

The Vice-Chancellor further noted that the **Chairperson and members of the Selection Committee** may be formally and confidentially recommended and in principle, the approval to be taken by the EC. The Council agreed unanimously.

Agenda Item 4: Declaration of PhD Admission Results (Annexure 3.a)

Discussion:

The Vice-Chancellor informed the Council that the PhD admission results had been temporarily withheld due to limited faculty availability for supervision. However, it was clarified that the PhD coursework extends over a year, and research supervisors are typically assigned upon its completion. During this initial phase, core faculty members are responsible for supervising and delivering the coursework components.





Resolution:

The Council recommended that the **PhD admission results be declared**, and the selected candidates be allowed to join along with new entrants on **21 July 2025**.

Welcome and Opening Remarks

• The meeting began with a brief welcome note from the Vice-Chancellor & Chairman of the Academic Council.

Agenda Items and Detailed Discussions

I. Confirmation of the Minutes of the last Academic Council meeting (Annexure 1)

- The minutes of the previous meeting held on 20th November 2024 were reviewed and approved without amendments.
- Prof. Syiemlieh sought a clarification was raised regarding references to the "Council" in the previous minutes, which could lead to confusion. It was decided that such references should be detailed in specific sections—whether Academic Council or the internal councils—to avoid misinterpretation.

II. Reporting Items

1. Academic Calendar for 2025 (Annexure 2)

- Academic calendar dates were confirmed; with the caveat that certain state holidays which could be notified later can be incorporated; corrections for local holidays were incorporated.
- Two additional programmes were incorporated into the calendar to focus on mental health:
 - World Mental Health Day
 - World Suicide Prevention Day
- The Academic Council acknowledged the ongoing mental health awareness activities on campus, including the availability of a counsellor and referrals for students facing mental health issues.

2. Faculty Bootcamp (February 2025) (Annexure 3)

- The renaming of the Faculty Retreat to "Faculty Bootcamp" was presented.
- \circ $\;$ The bootcamp, held from 3^{rd} to 7^{th} February, included the following:
 - Recap of the first academic year.
 - Refinement of the standard course template for the five-year programme.
 - Academic exercises focusing on advisory courses and assessment criteria.
- A health camp and an online seminar were also conducted to support faculty development.

3. Winter Internship Programme (January–February 2025) (Annexure 5)

- The Winter Internship Programme, spanning eight weeks, was noted as the longest internship programme among law schools in India.
- Key highlights included:
 - First-year students interned with NGOs and Legal Services Authorities.
 - Second-year students were placed with District Courts, National Legal Services Authorities, and organizations such as the National Women's Commission.
 - Structured internship policies and feedback mechanisms were implemented.
- o The Academic Council acknowledged the importance of such internships in enhancing practical exposure and skills.

4. Admissions Report for 2025 (Annexure 6)

- A total of 677 sign-ups were recorded, marking a 56% increase from the previous year.
- Examination centres were finalized in eight cities, including Delhi, Mumbai, and Chennai, for the entrance exam scheduled on 5th April 2025 (Saturday).
- Outreach initiatives included presentations at district headquarters and placements in local and national newspapers to encourage local and national applications.

5. Research and Knowledge Management Cell (RKMC) Project Updates (Annexure 7)

- The RKMC is currently managing **13 ongoing projects**, with the following key highlights:
 - A new project funded by the UK, with a grant of £65,312.50
 - An ICSSR project funded with ₹5 lakhs.
- The approximate total funding for projects is ₹2 crores, contributing significantly to the university's research growth.

III. Approval Items

1. Structuring of Non-Taught Courses (Annexure 8)

- A detailed framework for undergraduate and postgraduate non-taught courses was presented, highlighting advisory courses and seminars to enhance research and presentation skills.
- Assessment methods were standardized, focusing on pass/fail criteria to ensure continuous improvement.

2. Faculty-Related Matters (Annexure 9)

- Two research fellows were appointed:
 - Dr. Krishna Nair J, Ph.D. in Economics.
 - Mr. Manjish Pal, submitted Ph.D. in Computer Science.
- o It was clarified that these appointments were for research fellows, **not** faculty positions.

3. Amendment to the Ph.D. Regulations 2023 (Annexure 10)

The Academic Council approved an amendment revising the eligibility criteria for Ph.D. scholars in the working professional category from 2 years of experience to 10 years of experience.

 - (1) The committee unanimously agreed that the drawings as prepared and submitted by the PWD (Buildings) to National Law University of Meghalaya stands approved as is. However, it is noted that there might be slight variations in the open spaces viz., the entrance lobby areas and other free areas of both buildings which may be utilized for other purposes etc.
 - (2) The Chairperson also directed the Executive Engineer and the Junior Engineer present to submit the final cost estimates for the buildings at an earliest in order for the committee to submit the same to the Law Department, Government of Meghalaya for the purpose of sanctions and approvals.
 - (3) The Chairperson along with all members present unanimously agreed that due to the University's urgent requirements and need for the building, before the commencement of the Academic Year 2025 from 01st July 2025, and the paucity of time; the renovations and repair works are to be started immediately under the supervision of the PWD (Buildings) and PWD (Electricals).

ii) Electrification - Drawings and estimates

(1) It was informed to the committee that the Junior Engineer (Electricals) is yet to submit the final drawings and cost estimates for the electrical works of both buildings owing



to the fact that there are changes to be made and to be finalised before submission to the committee.

(2) It was directed that the same needs to be submitted at an earliest in order for the committee to submit the same to the Law Department, Government of Meghalaya for the purpose of sanctions and approvals.

- b) Matters relating to the furnishings of the newly handed over buildings (Hostels and Classroom) handed over to NLU Meghalaya particularly to the items floated via tender no NLUM/Estt/Fur/67/2024/788 dated 19th May 2025
 - (1) Costs, Items and Award of Contract
 - (a) It was brought to the attention of the committee that the University had previously floated a tender for the furnishings (Classroom Chair, Classroom Table, Hostel Flexible Chair, Hostel Bed, Hostel Cupboard, Hostel Flexible Study Table, Hostel Bed Mattress) via tender no NLUM/Estt/Fur/67/2024/788 dated 19th May 2025.
 - (b) The Tender Evaluation Committee for the tender had in its meeting minutes held on the 10th June 2025 noted the below observations: -
 - (i) M/s Taste Jingkieng is L2 at INR 48,03,163.98/- for all items, after L1 M/S Digital Hardware (INR 44,43,296.00/-) being rejected since the items offered in their tender proposal are not as per the requirements of the University.
 - (ii) L1- M/S Digital Hardware was rejected as the items quoted by the bidder do not align with the University's requirements as per the amended notification no. NLUM/Estt/Fur/67/2024/811 Dated 26th May, 2025 of the tender document. It was noted that although sample images were not provided and site visit was not undertaken due to paucity of time, the necessary details were verified from the brand's official website.
 - (iii) L3 is M/s Khaitan Carpet Corporation at INR 57,34,859.00/- for all items
 - (iv) However, the Tender Committee noted that the offered items by M/S Taste have deviations from the dimensions as submitted by the PWD officials (Deputy and Assistant Architect) on the 10th June 2025. Hence, the Tender Committee unanimously decided to reach out to the bidder to confirm whether they can provide the said items at the dimensions provided by the PWD officials at the same offered price, subject to minor deviations. (email sent to the bidder on the 10th June 2025)
 - (v) The Tender Committee recommended that if L2 can offer the items as per the University requirements (dimensions, quality, price), then L2 is suggested for supply of all items, however if L2 cannot offer the items as per University



- requirements, then a breakup of items to be supplied by L2 and L3 as per item wise rates, quality and required dimensions is recommended.
- (vi) The Tender Committee also recommended that either L2 or L3 can provide the items subject to their delivery time due to the paucity of time and urgent requirements of the University.
- (c) The Project Management Committee noted the observations made by the Tender Committee and also noted that the items provided by the L3 Bidder, M/s Khaitan Carpet Corporation, conform to the dimensions as stated by the PWD Officials which would fit in the buildings in question although at a higher cost than the L2 bidder.
- (d) The room was briefed that L2, M/s Taste, had responded to the email enquiry sent by the University's Tender Committee as on the timing of the meeting of the Project Management Committee with items as per University Requirements.
- (e) The Chairperson and other members present unanimously decided that owing to the paucity of time and urgency of requirements and considering the delivery period of all items which might be caused by further delay of officially communicating with the bidders for the supply, L3 can be issued the supply order for the items where L2 initially does not meet the requirements of the University. (Annexure 1)
- (f) The Project Management Committee also observed that all suppliers/vendors engaged by the University should adhere to the Khasi Hills Autonomous District Council's (KHADC) trade and labour laws by way of providing licenses/registrations/documents as applicable.
- (g) The Project Management Committee directed the University to submit the costs and estimates for the same in order for the committee to submit them to the Law Department, Government of Meghalaya for the purpose of sanctions and approvals.

c) Matters related to the IT items to be installed in the Hostel and Classroom

- (1) It was reiterated to the room that the Junior Engineer (Electricals) is yet to submit the final drawings and cost estimates for the electrical works of both buildings owing to the fact that there are changes to be made and finalised before submission of the committee.
- (2) It was also informed to the room that the final IT equipment (Smart Classrooms, Wi-Fi, CCTV, PA Systems etc) have not been finalised by the University in consultation with the PWD (Electricals) as on date.
- (3) It was again reiterated that the same needs to be finalised and submitted at an earliest in order for the committee to submit the same to the Law Department, Government of



Meghalaya for the purpose of sanctions and approvals.

4) The meeting ended with a vote of thanks from the Chairperson.
